As you know, Wyoming is an advisory member of SBAC. While it's not certain we will be implementing the Consortium's assessment in the spring 2015, we plan to continue to keep you informed as the assessment develops. On December 4, SBAC released a technology planning framework for member states preparing to implement the assessment system in the 2015-15 school year. The framework provides minimum hardware specifications and basic bandwidth calculations that will allow schools and districts to evaluate which of their existing devices will support the administration of next-generation assessments.

Users will be able to go to the bandwidth checker, choose a test mathematics or English language arts), and then enter the number of students who will be testing at one time. The bandwidth checker is hosted at <a href="https://sbac.tds.airast.org/networkdiag/Pages/LoginShell.aspx?section=sectionDiagnostics">https://sbac.tds.airast.org/networkdiag/Pages/LoginShell.aspx?section=sectionDiagnostics</a>. It can be run using modern versions of Mozilla Firefox on computers with Windows, OS X, or Linux operating systems; Safari on tablets using the iOS operating system; and Chrome on tablets using the Android operating system. The bandwidth checker cannot be accessed using Internet Explorer.

SBAC estimates that the majority of schools will be able to successfully administer the assessments with their existing infrastructure. I encourage you to share the framework with appropriate staff and to begin evaluating the suitability of existing computers for the Smarter Balanced assessment system in the event Wyoming adopts the assessments for implementation in the 2014-15 school year. #### Smarter Balanced Assessment Consortium -- Spring 2013 Pilot

In November, SBAC formally announced opportunities for schools to participate in the first pilot of the new assessment during the window of February 20 - May 10, 2013. As noted in the WDE's November

Memorandum to Superintendents, SBAC has created a pilot option for interested volunteer schools to administer a released sample set of items during the second half on the window. This volunteer option allows school staff in all member states, including Wyoming, to gain greater exposure to the CCSS and the next generation assessment item types and formats. # **NAEP Updates**

Click <u>here</u> for information about the Wyoming State Assessment. 2013 NAEP assessment window opens next week (Monday, January 28<sup>th</sup>) and runs through March 8. NAEP pre-assessment or planning meetings have been conducted at schools during January as a preparation step prior to the window's opening.

A major focus in planning meetings has been to ensure that as many of our state's students with disabilities and students who are English language learners as possible are included in NAEP testing. High inclusion rates lend credibility to Wyoming's grade four and eight NAEP results, and are in keeping with Wyoming's *Equality State* motto.

Some key points:

- Nearly all accommodations allowable on PAWS are also available to students with disabilities and students who are English language learners on NAEP,
- As a result, all students assessed on the general PAWS—with or without accommodations—should be *included* in NAEP testing,
- Students taking the PAWS-ALT, however, should be <u>excluded</u> from NAEP,
- Keep in mind that a "read aloud" accommodation, beyond clarification of assessment directions, is not allowable on PAWS reading tests—nor is it allowed on NAEP reading. Therefore, need for a "read aloud-all" accommodation is neither a valid rationale nor criterion for excluding students on NAEP's reading assessment.
