

Results on the 2015 National Assessment of Educational Progress, known as the Nation's Report Card or NAEP, show Wyoming's fourth and eighth grade students continue to outperform national average test scores in reading and mathematics.





Wyoming is one of **23** states that the U.S. Department of Education has determined meets the requirements and purposes of the Individuals with Disabilities Education Act.



Quality Counts 2016 gave Wyoming an overall score of **80.2** out of 100 points and a grade of B-minus, the highest score among western states and above the nation's overall grade of C.



377 public comments have been gathered through 10 public meetings and online forms during the review of Wyoming's science standards.

Superintendent Balow was named one of the **2016 Most Influential in State & Local Government** honorees by the National AfterSchool Association.






#### NATIONAL ASSESSMENT OF EDUCATIONAL PROGRESS


Wyoming Average

# THE EVERY STUDENT SUCCEEDS ACT

The Every Student Succeeds Act (ESSA) reauthorizes the Elementary and Secondary Education Act to create a long-term, stable federal policy that gives states additional flexibility and encourages innovation, while at the same time holding us accountable for results.

- Limits power of federal government to set education policy for states
- Increases state flexibility to design accountability systems, interventions and student supports
- Increases state and local flexibility in the use of federal funds
- Gives states flexibility to work with local stakeholders to develop educator evaluation and support systems
- Maintains annual assessments for grades 3-8 and high school

# SUPERINTENDENT'S LETTER

Dear Friends and Citizens of Wyoming,

My #1 goal as your State Superintendent is to support and grow the most important work in education – the learning and teaching that happens every day in classrooms. Here are a few areas where we are working hard:

#### Career and technical education (CTE)

Whether students go to college, career training, the military, or the workforce, CTE coursework provides valuable practical and academic opportunities for students.

- + It's estimated that more than half of the jobs in Wyoming require something other than a traditional college degree.
- + In 2013, 93% of Wyoming students who took three or more CTE courses graduated from high school in 2013. The same year, Wyoming's statewide four-year graduation rate was 78%.

#### Financial literacy

Too few young adults possess "financial literacy" or the ability to make informed and effective decisions with all of his or her financial resources. Wyoming is no exception.

+ All students should understand their own personal finances and the economic impacts of their choices in life.

#### Improving education outcomes for all students

Citizens from across the state provided input on what is most important in Wyoming education. From this input, Wyoming adopted a statewide vision for education, *Career, College, and Military Ready: Creating Opportunities for Students to Keep Wyoming Strong.* Accomplishing our goals is only possible when we work together.

+ I am very proud of the strong and unprecedented partnerships built with parents, communities, schools, higher education, and business.

We can't talk about education in Wyoming without addressing the fact that Wyoming is in an economic downturn. Cuts have occurred in school districts and the WDE, and money for school construction is set to run out in a couple of short years. I will continue to work to keep cuts as far away from the classroom as possible, but even more than that I want to assure you that we will continue our efforts to grow what we have. The foundation for education in Wyoming is strong and I am firmly committed to helping us all withstand this storm and turn out stronger teachers, stronger students, and stronger communities.
