PUBLIC HEARINGS
CHAPTER 31: REVISED WYOMING CONTENT STANDARDS FOR
MATH, LANGUAGE ARTS, AND HEALTH

Cheyenne- As indicated in the Press Release dated December 22, 2011, public hearings for the Chapter 31 Rules have been set up around the state beginning Monday, February 6th and continuing through Monday, February 13, 2012.

Attendance Procedure:

Members of the public may arrive twenty minutes before the scheduled start of the hearing session. Upon arrival, visitors will need to *sign in* if they wish to speak. If any person would like to share a comment, but does not wish to speak publicly, they may submit a written comment during the public hearing instead. Participants are free to leave after sharing their comments, or they may stay and observe the entire hearing.

Hearing Room Protocol:

- Participants wishing to speak at the public hearing **MUST SIGN THE SIGN-UP SHEET** and indicate which standard(s) they are commenting on.
- When taking the microphone, speakers shall state their name and resident district or town.
- Each speaker will be permitted three (3) minutes to share his/her comment. If at the end of the allotted time the speaker would like to share additional comments, he/she may sign up to speak again or submit a written comment.
- All members of the public will treat others at the public hearing with respect; no interrupting, clapping, booing, or hissing will be permitted.
- All cell phones or pagers must be turned off or on vibrate.
- Public hearings are **NOT** question-and-answer sessions or debates. Every person who shares a comment during the public hearing will receive a written response from the State Board of Education.
- When the public hearing is officially declared closed, no further comment will be allowed.
