## COMPETITIVE TEACHER/LEADER QUALITY SUB-GRANTS AVAILABLE

**PROPOSALS DUE OCTOBER 30** 

The Wyoming Department of Education (WDE) is requesting project proposals from educational agencies and schools, as well as from the business community in order to award funding for No Child Left Behind (NCLB) grants. The WDE administers competitive grants as authorized by the NCLB act, under Title II, Part A, Subpart 3 (II-A Subpart 3). II-A Subpart 3 is designed to improve student achievement through proven tactics, and to hold local educational agencies and schools accountable for improvements in student achievement.

Wyoming has \$268,128.00 available to award to qualified applicants on a competitive basis. Proposals are due on October 30, 2015 by 5:00 p.m., and awards will be made as soon as possible after November 30, 2015. The award period will be December 1, 2015 to September 30, 2017. Awards are expected to range upward from \$25,000.

Proposals must consist of high quality professional development opportunities in core subject areas for teachers, principals, and highly-qualified paraprofessionals. These opportunities must be in partnership with institutions of higher education.

Partnerships must include:

- An institution of higher education that offers educator preparation programs
- An institution of arts and sciences
- A high-need local educational agency (listed in the attached document)

Other districts may join a partnership that includes a high-need district, and are strongly encouraged to do so.
