

Student Data Elements

For students enrolled during the current school year: Submit one row every time a student enrolls in the district, including at the beginning of the school year. In addition, report a new row for the student when any of the following fields change:

- SchoolID
- StudentGradeLevel
- StudentConcurrentEnrollment
- StudentHomeSchooled

StudentIDEA

For the fields StudentIDEA, StudentELL, StudentELLMonitoring, StudentSection504, StudentTitle1, StudentMigrant, StudentImmigrant, StudentHomeless, StudentGiftedTalented, and StudentLunch, report the value the student had during the period bounded by StudentEntryDate and StudentExitDate. If the period bounded by StudentEntryDate and StudentExitDate contains the snapshot date for the collection (October 1), then report the value on the snapshot date.

For correcting exit status from previous years: This report may also be used to correct the StudentExitType for any student in previous years. In that case, report one row per student per school and specify the correct exit status and exit type for that student. The StudentEntryDate and StudentExitDate should both be from the previous school year and the grade level should be the student's grade level at the end of the previous school year. For the fields StudentIDEA, StudentELL, StudentELLMonitoring, StudentSection504, StudentTitle1, StudentMigrant, StudentImmigrant, StudentHomeless, StudentGiftedTalented, and StudentLunch, report the value the student had on StudentExitDate.
