- SUBJECT: School District Accreditation

CHANGES TO ACCREDITATION PROCESS FOR 2018-19

The Wyoming Department of Education (WDE) plans to implement a new state-led accreditation process beginning in the fall of 2018, making a regional accreditation process optional for Wyoming districts and schools. Although the WDE values the AdvancED accreditation process and partnership, reductions to the state budget make it unrealistic for the WDE to continue to provide AdvancED accreditation for all districts and all schools in Wyoming. District survey feedback was also considered in this decision.

The New Wyoming Accreditation Process:

- The process will include 25 Wyoming accreditation criteria which are based on education research and the requirements of Wyoming statute.
- Districts will implement processes aligned to these criteria in a manner consistent with Wyoming statute.
- The WDE will monitor district adherence to these criteria through an annual accreditation report, existing monitoring processes, and additional monitoring as necessary.
- The accreditation report will result in shared practices and will provide statewide information on district support needs.
- The WDE will make an accreditation recommendation to the State Board of Education for all districts annually based on adherence to the criteria. District accreditation will include all schools governed by the district.

• Compliance issues with a district or its schools will result in a reduction of annual accreditation status in accordance with Chapter 6 rules and regulations. Please note that revisions to Chapter 6 are currently in progress.

The WDE will convene an Accreditation Task Force to make recommendations regarding optional processes and external reviews. These may include a peer review process or an external review by a third party vendor.

The WDE is seeking participants to serve on the Accreditation Task Force beginning in November of 2017. Those interested in serving on this task force should contact Bill Pannell no later than Friday, October 13, 2017.

Note: The WDE will continue to require AdvancED accreditation for schools that are not governed by a Wyoming school district and that receive state education funds (i.e. institutional schools).
