## **ACT Test Accessibility and Accommodations System**

As many of you are preparing for the ACT assessment this year, you may also be gearing up for the submission of accommodations information to ACT. The Wyoming Department of Education must ask you to hold off on sending this information at this time. We are still in contract negotiations and until the contract is finalized, NO confidential student information should be shared with ACT. We will let you know when the contract is final and it's ok to submit supporting information for the accommodations requests.

## **NEW: Doman Reports In Fusion are Now Available**

Some of you have been awaiting the release of the new domain reports for PAWS, and we are pleased to announce that they are now available in Fusion. These reports will show – by grade and subject in your school – performance by domain (aka strand). This will help highlight relative areas of strength and need within mathematics, reading, and science. Please remember that we only have about 6-8 items per domain (e.g. algebraic relationships or key ideas and details), so you will need to avoid over-interpreting these data. We're already contemplating improvements to the reports for next year, employing graphics that will make it easier to see relative strengths and weaknesses and acknowledging the measurement error that's inherent in these kinds of drill-downs.
