# SAWS Professional Development Opportunity (How ARE those Papers Scored?)

The Wyoming Department of Education and Educational Testing Service (ETS) will be providing four, half-day Online Training Sessions on Scoring SAWS Responses for Wyoming 3-8 teachers. These sessions will provide training on how to score 12-point Wyoming Student Assessment of Writing Skills (SAWS) essays. The training will be facilitated by the Chief Scoring Leader for SAWS and ETS Assessment Development staff.

Participants will join an online Microsoft Live Meeting and call-in. They will then:

- walk through the certification process (qualifying for being a rater for SAWS scoring, benchmark papers and annotations, and rater training materials) for scoring a Grade 3 or Grade 6 Expressive prompt.
- log-in to ETS's Online Scoring Network (OSN) system and have the opportunity to score at least one set of Grade 3 or Grade 6 responses (depending on the session) in the OSN system and see the functionalities for interacting with Scoring Leaders, either by phone or e-mail.
- interact with the Chief Scoring Leader for SAWS after she reviews the scores from participants in the OSN system and explains why each response received its "true score."
- learn how to become a rater for scoring SAWS responses this spring.

Grades 3-5 (using Grade 3 papers)

 March 5<sup>th</sup> 4 p.m. – 8 p.m. March 6<sup>th</sup> 3 p.m. – 7 p.m.

Grades 5-7 (using Grade 6 papers)

 March 12<sup>th</sup> 3 p.m. - 7 p.m. March 13<sup>th</sup> 4 p.m. - 8 p.m.

# Participant Eligibility Requirements:

- Must be a certified K-12 teacher and currently employed by a Wyoming school district
- Must have access to a personal computer that accommodates the minimum PC requirements found <u>here</u>. NOTE: Macintosh computers are not currently supported. (However, Macintosh computers *will* be supported for the spring SAWS scoring.)

**Participant Stipend:** Participants will be paid **a \$125.00** stipend for a half-day session

#### **Common Core State Standards and Traffic Signal Report Survey**

### Hathaway Eligibility and Accommodations on the ACT

All students taking the ACT state assessment will be considered for the Hathaway Scholarship. This includes students with both ACT-approved accommodations and those who receive state-allowed accommodations. ACT approval of accommodations does not determine state scholarship approval.

#### **Exemptions for Out of State Placements**

In 2013, we are not permitting out of state testing for students who are officially enrolled in a Wyoming school. To ensure that WDE takes students with out of state placements out of your school's denominator for calculation of participation rates, you must complete an exemption form, <u>WDE673</u>.

#### **Writing Scoring Guides Updates**

#### **Test Ethics and Test Security**

Maintaining test security is important to ensure that decisions made at the student, classroom, school, district, and state levels are made with valid and reliable data. At WDE, we work with our test vendors as well as Wyoming teacher teams to ensure that our assessments meet technical standards with respect to fairness, reliability, and validity. School and district staff are also responsible to ensure that all aspects of test preparation, administration, and security are appropriate and in no way compromise the integrity of the assessment system.

So that all of those involved in PAWS and SAWS assessment are aware of appropriate practices for test preparation, administration, and security, WDE publishes *Directions for Administration* and *Building Coordinator's Manuals*. Each of the documents contains an appendix with a Test Administrator Security Agreement that is to be signed by staff involved in testing. Please train appropriate staff using information in the manuals and then retain records of the signed Security Agreements from the participants. In addition to the manuals, you may use a slide presentation on test security located <u>here</u> on the WDE website.

#### ACCESS for ELLs

Wyoming is a member of the WIDA (World Class Instructional Design and Assessment) consortium. Thirty one U.S. states and territories now belong to the WIDA Consortium. Among WIDA's purposes is the development of assessments for English Learners (ELs) that meet and exceed the goals of No Child Left Behind. ACCESS for ELLs<sup>TM</sup> (Assessing Comprehension and Communication in English State-to State for English Learners) is the required annual assessment given to English learners in Kindergarten through twelfth graders to monitor students' progress in acquiring academic English. The ACCESS testing window for 2013 opens on February 4<sup>th</sup> and closes March 8<sup>th</sup>. This window is shorter than in previous years and allows for score reports to be returned to Districts beginning May 15 through May 18. Receiving score reports earlier should help in planning for next year.

The shorter testing window means that there may be new to the country / first year in school in the US students that enter districts after March 8<sup>th</sup>, are identified as ELs, and do not take the ACCESS for ELLs assessment. These new to the country / first year in school in the US students that are identified as ELs, will not be eligible for the Reading exemption on PAWS. These students will need to take the Reading portion on PAWS in order to meet participation rates.

Note: Score reports will not be sent to any district until all districts in Wyoming have shipped completed test materials to MetriTech. The deadline to ship materials is March 14, 2013.

#### Alternate ACCESS for ELLs

This year Wyoming is offering the Alternate ACCESS for ELLs, an assessment of English language proficiency for students who are classified as English learners and have significant cognitive disabilities that prevent their meaningful participation in the ACCESS for ELLs<sup>™</sup> assessment. Dates for administration of the Alternate ACCESS for ELLs<sup>™</sup> are the same as the ACCESS for ELLs<sup>™</sup>, February 4 – March 8. #### **ASSETS Consortium**

Wyoming is also a member of the ASSETS consortium. ASSETS is a 30-state consortium, building on the work of the WIDA consortium, to create the next generation of English Language Proficiency tests. This work is supported through a federal Enhanced Assessment Grant (EAG). This grant supports the development of a technology-based assessment system for English learners. The transition to a computerized version of ACCESS for ELLs<sup>™</sup> is scheduled for 2015-16.
