## HATHAWAY SUCCESS CURRICULUM \& REQUIREMENTS

Beginning with the graduating class of 2016, for the Honors and Performance levels of the Hathaway Scholarship, students will need to complete all of the 2011 requirements (shown below) plus two additional years of foreign language or two years of Fine \& Performing Arts or two years of Career/Technical Education.

Honors

- Math- 4 years of math
- Must include Algebra 1 \& 2, Geometry and an additional math
- Language Arts- 4 years of Language Arts
- Science- 4 years of science
- Social Studies- 3 years of social studies (five content areas must be covered in 3 years)
- Foreign Language 2 years of sequenced foreign language (i.e. Spanish 1 and Spanish 2)
+3.5 Grade point average and 25 ACT
Performance
\$1,260 per semester
- Math- 4 years of math
- Must include Algebra 1, Algebra 2, Geometry and an additional math
- Language Arts- 4 years of Language Arts
- Science- 4 years of science
- Social Studies- 3 years of social studies (five content areas must be covered in 3 years)
- Foreign Language 2 years of sequenced foreign language (i.e. Spanish $1 \& 2$ )
+3.0 Grade point average and 21 ACT

All current HSC requirements (as of 2011) for the Opportunity and Provisional Opportunity levels of the Hathaway Scholarship are the same with the exception of the foreign language proficiency requirement. Beginning with the graduating class of 2016, students will need to complete all of the 2011 requirements in math, language arts, science, and social studies. In lieu of the current foreign language proficiency requirements, students will choose two sequenced years of foreign language or two years of Fine \& Performing Arts or two years of Career/Technical Education.

## Hathaway guidelines that may/may not have implications for CTE course approval:

1. Requirements for verification of course

Curriculum Directors must provide:
Course Name as it will appear on final high school transcript.
Course Category (i.e. Physics, Chemistry, Algebra I, Geometry)
Course Description
SCED code and/or course description
Delivery Mode
Content specialists may request additional information, including:
Course Syllabus
Proof of alignment to WY content standards
Course assessments
** The above requirements for course verification is a simple process and should not affect CTE course approval.
2. A course must meet one full year of content to qualify as a year-long course.
**This could potentially be an issue with some CTE courses, since many are semester courses.
3. If a district wants to use courses from a community college (i.e. dual enrollment courses), the name of the college must be identified in order to be approved for Hathaway use. Please note: a course description and a list of WY content standards may be requested.
** This should be seen as bonus for CTE course approval numbers, as many dual enrollment courses also include industry certification and should align with standards.
4. If a software program (i.e. Rosetta Stone, Odyssey Ware, PLATO, etc.) is being used to satisfy Hathaway Success Curriculum requirements, all coursework and assessments MUST align to the WY content standards in order to be approved.
5. ** This should be a positive for CTE courses, as many are using Project Lead the Way (PLTW) which align to WY content standards.

## TRANSITIONS FROM WYOMING CTE SECONDARY EDUCATION

- The data below is the most current CTE data reported for the 2012-2013 Perkins funding year.
- At the secondary level, a CTE participant is defined as a secondary student who has completed one or more courses in a CTE program sequence.
- At the secondary level, a CTE concentrator is defined as a secondary student who has completed three or more courses in a CTE program, including those who may be currently enrolled in their third course.
- Placement follow-up data was collected on all CTE concentrators who left secondary education during the prior (2011-2012) school year (1,565 students and not only graduates).
- Placement follow-up data was collected during the second quarter (between October 1, 2012 and December 21, 2012).

1. Of the 1,525 placed CTE concentrators, $45.4 \%$ went on to community colleges.
**96.6\% In-state, 3.4\% Out-of-state
2. Of the 1,525 placed CTE concentrators, $21.8 \%$ went on to four-year universities.
**57.8\% In-state, 41.6\% Out-of-state
3. Of the 1,525 placed CTE concentrators, $3.9 \%$ entered an advanced training program (other than community college or four-year university).
**49.2\% In-state, 49.2\% Out-of-state, 1.5\% Unknown
