#### CALL TO ORDER

Chairman Pete Gosar called the meeting to order at 9:07 a.m.

Chelsie Oaks conducted roll call and established that a quorum was present.

#### APPROVAL OF AGENDA

Sue Belish moved to approve the agenda as presented, seconded by Jillian Balow.

Jillian Balow requested a Superintendent's Update be added to the agenda. Also, Pete Gosar requested the agenda be amended to include the Chapter 31 Rules and the SSoS Council Members under action items on the agenda.

Sue Belish moved to amend the agenda with the requested content added, seconded by Kathryn Sessions; the motion carried.

#### APPROVAL OF MINUTES

Minutes from the October 8, 2015 and September 2015 Retreat were presented to the Board of approval.

Kathryn Sessions moved to approve the minutes from the October 8, 2015 meeting, seconded by Nate Breen; the motion carried.

Ken Rathbun moved to approve the minutes from the September 2015 Retreat, seconded by Walt Wilcox.

Sue Belish suggested that all requests made by the State Board of Education be posted in a memo, with a bulleted list, the day after a meeting.

Kathy Coon wants to do a better job monitoring the request made by the Board.

Paige Fenton Hughes, SBE Coordinator, will add an "Old Business Section" to the agendas and make sure to send a follow up memo on requests.

The motion carried.

Scotty Ratliff requested that another memo be forwarded to the Dean of Education at the University of Wyoming to attend the State Board of Education meetings.

#### SUPERINTENDENT UPDATE

Superintendent Balow apologized for appearing by phone, she was on a panel the previous day in Ohio discussing rural education. She asked that a Superintendent Update be included at every meeting.

Superintendent Balow discussed the WDE's strategic plan and vision with the Board. The Board asked in-depth questions, it was eager to see the direction the department was going, and commented that sharing the plan with more entities and presenting the plan in phases would be beneficial.

Walt Wilcox requested that the Board and the Department do more of the strategic work together.

#### STATEWIDE SYSTEM OF SUPPORT

Brent Young, WDE liaison, discussed the progress of the Statewide System of Support. Fifteen schools, in twelve districts have been identified as "not meeting expectations" in the accountability model. The Board requested that those schools and districts be notified as soon as possible, because district's improvement plans are due December 7<sup>th</sup> and these findings will affect what they submit.

Dr. Joel Dvorak discussed the SSoS Collaborative Council and described how the learning system at the classroom level is the most important. The Council is scheduled to meet November 8-9, 2015 in Casper.

Sue Belish requested a monthly written update be sent to the Board, to include all the milestones of the system and a detailed description of how and when those milestones are met.

#### JEC & SELECT COMMITTEE REPORT

SBE Coordinator, Paige Fenton Hughes, gave the Board a brief update on submitting the October 15<sup>th</sup> Report to LSO and the Joint Education Committee (JEC) and the Select Committee on Statewide Education Accountability meetings that will take place Thursday and Friday after the Board meeting. She also reviewed the Board Update memo provided in the meeting packet on the work she has been doing.

Paige Fenton Hughes, extended an invitation to the Wyoming Schools Boards Association conference November 18-20 in Casper. Nate Breen, Sue Belish, and Ken Rathbun will be in attendance, but if other members would like to attend to please notify Chelsie Oaks.

#### SBE GOALS

Paige Fenton Hughes reviewed the list of SBE Goals in the packet. Sue Belish suggested the Board consider switching the order of the list and asked that there be an alignment of SBE goals and legislative priorities.

Walt Wilcox felt that the last bullet, starting with "Lead in developing" was not appropriate and also felt that it is important that all parties support and appreciate what collaborative is.

Nate Breen and Sue Belish agreed, Sue Belish noted that the Board should want to encourage collaborative work but supporting and participating.

Pete Gosar requested that Board members forward their comments and suggestions on the goals to Chelsie Oaks.

#### LEGISLATIVE AGENDA

SBE Coordinator, Paige Fenton Hughes, reviewed the list of legislative priorities provided in a memo within the meeting packet. Paige felt that the Board should put the list in a different format than previous years. Sue Belish felt that both the goals and legislative priorities of the Board should be reworked to mesh together.

Pete Gosar requested that the Board hold on action until the goals and legislative priorities are worked out a little more; they will be presented at the next State Board of Education meeting.

#### **DEFINITION OF A HIGH SCHOOL GRADUATE**

Paige Fenton Hughes, reviewed the work that was completed on the definition of a high school graduate with the collaborative council in Saratoga. Paige also reviewed the Complete College Wyoming work provided in her memo to the Board; she felt that the Complete College Wyoming work was more complete than the definition document in the board packet.

Dr. Jim Rose, noted that the Complete College Wyoming definition was created with a focus on port-secondary education. Dr. Rose felt that the Board could use it as a template, but overall felt that the Board needed to create its own definition of a high school graduate and do it more concisely. He lastly noted that public education has a larger audience than post-secondary and that the Board's definition needs to reflect that.

The Board discussed what it would like to see the definition include. Paige Fenton Hughes will bring a redraft to the next meeting.

#### COMMUNICATION COMMITTEE

SBE Coordinator, Paige Fenton Hughes, reviewed with the Board the recent Communications Committee call on October 14. The Committee reviewed the contract amendment for Pascal Public Relations.

Jim Rose commented that the committee took a good look at the deliverables and what the Board needed. He said the committee wanted to be deliberate about the services requested and not to over extend on what the Board really needs.

Dr. Fenton Hughes discussed some recent public input given to the Board on the communications contract and request for proposal (RFP). The Chairman, the person who gave the input, and Paige had a conference call to review issues and details.

#### COURT ORDERED PLACEMENT OF STUDENTS PROVIDERS

Jo Ann Numoto, WDE, presented on three facilities for court order placed students and gave additional information on each facility individually.

Kathryn Sessions moved that the SBE designate Excelsior Youth Center as an approved facility for court ordered placement of students and subsequent educational payments pursuant to Section 9 and 10 of Chapter 14, SBE Rules and Regulations and completion of the review, seconded by Nate Breen; the motion carried.

Kathy Coon moved that the SBE designate Shiloh Home, Inc./Shiloh House as an approved facility for court ordered placement of students and subsequent educational payments pursuant to Section 9 and 10 of Chapter 14, SBE Rules and Regulations and completion of the review, seconded by Ken Rathbun; the motion carried.

Kathryn Sessions moved that the SBE designate Norris Academy as an approved facility for court ordered placement of students and subsequent educational payments pursuant to Section 9 and 10 of Chapter 14, SBE Rules and Regulations and completion of the review, seconded by Sue Belish; the motion carried.

Board members requested more data on the number of students in and out of state placement, how many out of state facilities are available, and more information is provided on what is being done at the state level.

#### NASBE ANNUAL CONFERENCE

Nate Breen, Paige Fenton Hughes, Mackenzie Williams, Pete Gosar, and Chelsie Oaks all presented on the NASBE Annual Conference including the highlights and takeaways from the conference.

Chairman Gosar encouraged members to attend the next annual conference in Kansas City, Missouri.

#### **GOTOMEETING APP**

Chelsie Oaks, Board assistant, had all the Board members download the GoToMeeting App onto their iPads in preparation of the November meeting being conducted through GoToMeetings.

#### AMENDMENT TO PASCAL PUBLIC RELATIONS CONTRACT

Paige Fenton Hughes discussed the Pascal Public Relations amendment provided in the Board packet.

Sue Belish moved to approve the contract amendment for Pascal Public Relations, seconded by Walt Wilcox; the motion carried.

#### **CHAPTER 31 RULES**

SBE Coordinator, Dr. Paige Fenton Hughes, gave the Board information on why the Chapter 31 Rules needed to be rescinded. The Legislative Service Office (LSO) had concerns that the rules sent over to them are a reiteration of the statutes and that the district assessment systems are not delineated enough in the submitted rules. LSO warned that if the submitted rules are not rescinded they will be forwarded to the Management Council on the non-consent list.

Sue Belish moved to rescind the promulgation of Chapter 31 rules as adopted on October 8, 2015 and to direct WDE to move forward with revisions of the rules, seconded by Nate Breen; the motion carried.

#### SSOS COLLABORATIVE COUNCIL

Kathryn Sessions was appointed to the Statewide System of Support Collaborative Council.

#### OTHER ISSUES, CONCERNS, DISCUSSION AND PUBLIC COMMENT

Pete Gosar reviewed the requests that were made in the meeting for the meeting follow up memo.

Kathy Scheurman gave public comment on her appreciation of the level of conversation, the depth of understand and the amount of compassion that the State Board of Education has.



The meeting opened with a staff update on the CREG report and how revenue will affect the school funding model and school construction. As you can imagine, it was not a positive report due to the falling revenue picture over the next few years. They also heard information about school safety and security (follow up to a bill that did not pass during the last session). Superintendent Balow and her leadership team presented the yearly report on the state of the schools. Senator Rothfuss and Representative Throne presented draft legislation related to data privacy issues. This has been a big topic of interest for quite a while now. In the interim they have chaired a committee to examine the related issues and draft legislation. Dean Reutzel presented an update on the initiative at UW to bring the College of 70 Education to a level of preeminence. They are waiting to hear about a

Daniels Fund grant to support the initiative. The committee heard a report about work done to facilitate the transfer of credits from the community colleges to the university. The progress on this endeavor was very well received by the committee. Finally, Brent Young and the Hathaway team from WDE presented about ways to incentivize completion of higher level course work and perhaps using weighted grade point averages. The committee did not agree on a path forward at this time, and the issue will be considered at a later time.

The Wyoming School-University Partnership met in Casper on November 4. Topics discussed included the work of the literacy center at UW and the development of the system of support. Joel was there to share information and garner input about the system of support The Partnership is also considering a new fee structure to try to boost membership among smaller districts.

Please find in your packets a memo to the Tribal Relations Committee to go in their packets for the November 30, 2015 meeting in Lander. You will also see a reworked set of board goals and definition of a high school graduate as per your input at the last meeting. We can talk through those during the meeting.

Therefore, the fact that Wyoming has the lowest graduation rate in the nation for Native American students should be of concern to us all. Not graduating from high school makes it not only difficult for the student, but also for the children born to that student. Well-to-do students are two to three times more likely to have adult mentors outside the family and are much more likely to participate in extra-curricular activities at school, both indicators of school success. More than just telling parents to read to their children every day, coaching and training should be provided to help them learn with their children. And, advanced courses and rigorous careertechnical courses should be offered in all schools to all students.

> The state board has, for many years, encouraged the passage of legislation to strengthen statutes to incentivize school attendance. Wyoming has been working to create a robust education accountability system to hold schools accountable for student performance, but it's impossible for schools to educate children who don't attend regularly.

The board has also been encouraging collaborative partnerships in which 72 interested entities come together around educational issues to bring about

positive change. Communities must be partners in educating their youth. Schools cannot succeed alone. Wrap-around services from health care to social work to early childhood education are the keys to helping young children come to school ready to learn.

Optional universal early-childhood education opportunities are a must for Wyoming's children and families. In June you saw statistics provided by the Wyoming Department of Education (WDE) regarding the levels of kindergarten readiness for children on the Wind River Reservation. Greater focus on early childhood learning opportunities would provide a better chance to students to enter kindergarten with the kinds of skills they need to be successful and eventually graduate from high school.

The state board supports the implementation of a multi-tiered and comprehensive system of support for all schools, but particularly those schools, including those on the reservation, which do not meet expectations on the Wyoming Accountability in Education Act indicators. The board is statutorily charged with overseeing the development of such a system, and the WDE is in the process for planning a system at this time. Specific interventions aimed at school turnaround and supporting students from poverty must be part of a comprehensive system deployed by the WDE. The specific technical support for schools with critical needs is a vital component of a system of support.

Finally, the state board has supported the development of a curriculum about the history and culture of Wyoming's Native American tribes which can be shared with teachers from across the state and voluntarily included in instruction. Developing an awareness and understanding among those who live off the reservation and those who live on it is essential for our state as we tackle  $21^{\text{st}}$  Century issues that face us all.



Promulgation of regular rules began at the same time and on October 8, 2015 the state board adopted the regular rules. On October 28, 2015 the state board approved a motion to rescind Chapter 31 regular rules adopted on October 8, 2015 based on concerns voiced by the LSO staff. Revisions to Chapter 31 rules will be re-written to address these concerns.

The current emergency rules expire on December 15, 2015. W.S. 16-3-103 (b) allows the readoption of similar emergency rules for a second 120 day period. This is necessary to retain the authority to align graduation requirements with 2015 Senate Enrolled Act No. 87 which eliminates the tiered diploma requirement. In order to have available as much of the 240 days allowed for emergency rules as possible, the motion to readopt the emergency rules will direct the WDE to submit the request for approval to the governor on or before December 7, 2015.

### Wyoming Department of Education Chapter 31 Graduation Requirements Emergency Rules

#### STATEMENT OF REASONS

2015 SEA No. 87 eliminates the requirement for a high school diploma to provide an endorsement level to be stated on a student's transcript (tiered diploma). This legislation also eliminates district assessment system annual reporting and instead requires a review process that is part of district accreditation. These changes are effective with the 2015-2016 school year and will impact those students who meet graduation requirements this fall. Without these emergency rules, schools will be required to provide the tiered diploma endorsement on a student's transcript.

On August 14, 2015 the department submitted to the Governor a request for approval of emergency rules to immediately implement changes to Chapter 31 rules to support alignment with the legislative changes in 2015 SEA No. 87 and to eliminate the tiered diploma requirement and to eliminate the annual reporting requirement for the district assessment system. On August 18, 2015 the Governor approved emergency rules for 120 days.

On August 13, 2015 the department submitted to the Governor a request for approval to proceed with Chapter 31 Graduation Requirements regular rules promulgation. The Governor granted approval to proceed. The promulgation process moved forward and the board adopted the rules on October 8, 2015. On October 28, 2015 the state board approved a motion to rescind Chapter 31 regular rules adopted on October 8, 2015 based on concerns voiced by the LSO staff. Revisions to Chapter 31 rules will be re-written to address these concerns.

The current emergency rules expire on December 15, 2015. W.S. 16-3-103 (b) allows the readoption of similar emergency rules for a second 120 day period. This is necessary to retain the authority to align graduation requirements with 2015 Senate Enrolled Act No. 87 which eliminates the tiered diploma requirement and support schools who have students meeting the graduation requirements by not requiring the tiered diploma endorsement on the student's transcript. The additional 120 day period will support the department's need to modify the language in the revised rules and resubmit the documents to the Governor for approval to proceed with regular rules promulgation. The consequence of not approving the second 120 day period is a

### **Wyoming Graduation Requirements**

## EMERGENCY RULES ARE NO LONGER IN EFFECT 120 DAYS AFTER FILING WITH THE SECRETARY OF STATE

### Section 1. Authority.

(a) These rules and regulations are promulgated <u>under pursuant to the Wyoming</u> Education Code of 1969 (as amended - 2002) [W.S. 21-2-304 (a) (i) (ii) (iii) and (iv)].

### Section 2. Applicability.

(a) These rules and regulations pertain to the requirements for graduation from any public high school within any school district of this state. It is the intention of the state board of education to prescribe uniform student content and performance standards for the common core of knowledge and the common core of skills specified under W.S. 21-9-101(b) and to establish requirements for earning a high school diploma with which public schools (K-12) must comply.

### Section 3. Promulgation, Amendment, or Repeal of Rules.

(a) These rules and any amendments thereof shall become effective as provided by the Wyoming Administrative Procedures Act. (W.S. 16-3-101 through 16-3-115)

### Section 43. **Definitions.**

- (a) Advanced Performance. The level of performance as defined in the performance standards level descriptors contained in the sets of uniform student content and performance standards established for the Common Core of Knowledge and Common Core of Skills. [W.S. 21-2-304 (a) (iii) and W.S. 21-9-101 (b)]
- (<u>ba</u>) Common Core of Knowledge. Areas of knowledge each student is expected to acquire at levels established by the state board of education. [W.S. 21 9 101 (b)(i)]
- (eb) Common Core of Skills. Skills each student is expected to demonstrate at levels established by the state board of education. [W.S. 21-9-101 (b)(iii)]. These skills may be integrated into the uniform student content and performance standards for the Common Core of Knowledge.
- (d) Compensatory Approach. A compensatory approach for combining information allows higher scores on some measures (or standards) to offset (i.e., compensate for) lower scores on other measures. The most common example of the compensatory approach is the simple average. Within a single common core content area, students can use higher performance

on a particular standard, for example, to offset lesser performance on another standard and still be considered proficient in that content area (e.g., mathematics).

- (e) Conjunctive Approach. A conjunctive approach requires that scores on all measures used must be above the criterion point (cut score) for the student to have met the overall standard. Students must be above the cut score in all common core content areas to meet the graduation requirement.
- (f) Proficient Performance. The level of performance as defined in the performance standards level descriptors contained in the sets of uniform student content and performance standards established for the Common Core of Knowledge and Common Core of Skills. [W.S. 21-2-304 (a)(iii) and W.S. 21-9-101 (b)]
- (gc) School Years of English/Mathematics/Science/and Social Studies. With reference to Chapter 31, "school years" is defined as the credit earned during a school year which is synonymous with a Carnegie Unit of study that reflects the instructional time provided in a class calculated by multiplying the number of minutes a district uses for a class by the number of pupil-teacher contact days in the district calendar as approved by the <u>Ss</u>tate <u>Bb</u>oard of <u>Ee</u>ducation. This instructional time is usually between 125 and 150 hours in a calendar school year.
- (h) Standards for Graduation. The K-12 content standards contained in the uniform student content and performance standards established for the Common Core of Knowledge and Common Core of Skills. They define what students are expected to know and be able to do by the time they graduate. [W.S. 21-2-304 (a)(iii)]

### Section 5. Wyoming Statutes.

(a) All public school districts, and the schools and personnel within those districts, must comply with the applicable statutes of the State of Wyoming.

#### Section 6. Wyoming State Board of Education Policies and Regulations.

(a) All public school districts, and the schools and personnel within those districts, must comply with applicable state board policies and regulations. (W.S. 21-2-304)

### Section 7. Common Core of Knowledge and Common Core of Skills.

(a) All public school students shall be proficient in the uniform student content and performance standards at the level set by the state board of education in the following areas of knowledge and skills, emphasizing reading, writing and mathematics in grades one (1) through eight (8) (W.S. 21-9-101):

(a) Requirements for earning a high school diploma from any high school within any school district of this state shall include:

The successful completion of the following components in grades nine (9) through twelve (12), as evidenced by passing grades or by the successful performance on competency-based equivalency examinations:

(i) Four (4) school years of English;

- (ii) Three (3) school years of mathematics;
- (iii) Three (3) school years of science; and
- (iv) Three (3) school years of social studies, including history, American government and economic systems and institutions, provided b Business instructors may instruct classes on economic systems and institutions. [W.S. 21-2-304 (a)(iii)]
- (b) Satisfactorily passing an examination on the principles of the <u>eConstitutions</u> of the United States and the <u>sState</u> of Wyoming. <del>(W.S. 21-9-102)</del>
- (c) Evidence of proficient performance, at a minimum, on the uniform student content and performance standards for the common core of knowledge and skills specified under W.S. 21-9-101(a). A high school diploma shall provide for one (1) of the following endorsements which shall be stated on the transcript of each student:
  - (i) Advanced endorsement which requires a student to demonstrate advanced performance in a majority of the areas of the common core of knowledge and skills and proficient performance in the remaining areas of the specified common core of knowledge and skills, which include language arts, mathematics, science, social studies, health, physical education, foreign language, fine and performing arts, and career/vocational education, as defined by the uniform student content and performance standards;
  - (ii) Comprehensive endorsement which requires a student to demonstrate proficient performance in all areas of the common core of knowledge and skills, which include language arts, mathematics, science, social studies, health, physical education, foreign language, fine and performing arts, and career/vocational education, as defined by the uniform student content and performance standards;
  - (iii) General endorsement which requires a student to demonstrate proficient performance in a majority of the areas of the common core of knowledge and skills, which include language arts, mathematics, science, social studies, health, physical education, foreign language, fine and performing arts, and career/vocational education, as defined by the uniform student content and performance standards;

### Section 95. District Assessment System.

(a) Determination of proficient performance shall be demonstrated by the district and approved by the district board of trustees. [W.S. 21-2-304 (a)(iii) and (iv)]. Public school students shall be assessed in the uniform student content and performance standards at the level set by the state board of education in the following areas of knowledge and skills, emphasizing reading, writing and mathematics in grades one (1) through eight (8).

- (b) The assessment system shall be designed to best meet the needs of individual Wyoming school districts for certifying demonstrating whether or not students have mastered the common core of knowledge and skills as embedded reflected in the uniform student content and performance standards as specified in W.S. 21 9 101 (b) Chapter 10 of the Wyoming Department of Education rules. The assessment system described in this section shall be designed for grades nine (9) one (1) through twelve (12) and evaluated according to the following criteria: alignment, consistency, fairness, and standard setting be aligned with the uniform state standards, both in terms of content and cognitive complexity.
  - (i) Guidelines for each criterion shall be determined by the State Board of Education.
- (b) Beginning school year 2014-2015, each district's assessment system shall include a measure or multiple measures for purposes of determining completion high school graduation requirements.
- (c) At a minimum, districts shall use a compensatory approach for combining assessment information at the benchmark and standard level when determining whether students have met the performance requirements for each common core content area.
- (d) Districts shall use a conjunctive approach for combining assessment information across common core of knowledge and skills content areas to determine whether students have met the graduation requirements.
- (e) The district shall report to the state board in accordance with W.S. 21-2-304(a)(iv) on its assessment system on or before August 1, 2015, and each August 1 thereafter.
- (f) All Wyoming school districts with a high school shall submit their assessment system documentation to the Wyoming Department of Education according to the following schedule:
  - (i) For the 2003-2004 school year and all following years, districts shall submit yearly updates to their documentation to the Wyoming Department of Education. For the 2004-2005 school year and all following years, this documentation shall include the student performance results relative to the district's assessment system including disaggregation of passing rates. Each school district shall submit the documentation required by this paragraph no later than August 1of each year.
- (gc) For special needs <u>Districts shall provide</u> students <u>with disabilities</u> include accommodations in accordance with their individualized educational programs or 504 plans, and the policies as described in the Policies for the Participation of All Students in District and Statewide Assessment and Accountability Systems, which is available from the Wyoming Department of Education, 2300 Capitol Avenue, Hathaway Building, 2nd Floor, Cheyenne,

Wyoming 82002 0050. These accommodations shall not substantially alter the character of the assessments used to measure student performance.

### Section 10. Effective Date for Graduation Requirements.

(a) Beginning with the graduating class of 2003, each student who successfully completes the requirements set forth in Section 8(a) of this chapter will be eligible for a high school diploma. (W.S. 21-2-304(a)(iii) and (iv) and W.S. 21-9-102.) Thereafter, each student who demonstrates proficient performance on the uniform student content and performance standards for the common core of knowledge and skills listed in W.S. 21-9-101(a) of this chapter as set forth in Section 9 of this chapter and who also completes the requirements set forth in Section 8 of this chapter will be eligible for a high school diploma in accordance with the following timeline: (W.S. 21-2-304(a)(iii) and (iv) and W.S. 21-9-102.)

(b) Students graduating in 2006 and thereafter shall demonstrate proficient performance on the uniform student content and performance standards for language arts, mathematics, science, social studies, health, physical education, foreign language, career/vocational education and fine and performing arts as set forth in Section 8(c) of this chapter.

### Chapter 31

### **Wyoming Graduation Requirements**

## EMERGENCY RULES ARE NO LONGER IN EFFECT 120 DAYS AFTER FILING WITH THE SECRETARY OF STATE

Section 1. Authority. These rules and regulations are promulgated under W.S. 21-2-304(a)(iv).

Section 2. **Applicability.** These rules and regulations pertain to the requirements for graduation from any public high school within any school district of this state. It is the intention of the state board of education to prescribe uniform student content and performance standards for the common core of knowledge and the common core of skills specified under W.S. 21-9-101(b) and to establish requirements for earning a high school diploma with which public schools (K-12) must comply.

### Section 3. **Definitions.**

- (a) Common Core of Knowledge. Areas of knowledge each student is expected to acquire at levels established by the state board of education.
- (b) Common Core of Skills. Skills each student is expected to demonstrate at levels established by the state board of education. These skills may be integrated into the uniform student content and performance standards for the Common Core of Knowledge.
- (c) School Years of English/Mathematics/Science/and Social Studies. With reference to Chapter 31, "school years" is defined as the credit earned during a school year which is synonymous with a Carnegie Unit of study that reflects the instructional time provided in a class calculated by multiplying the number of minutes a district uses for a class by the number of pupil-teacher contact days in the district calendar as approved by the state board of education.

### Section 4. High School Diploma.

- (a) Requirements for earning a high school diploma from any high school within any school district of this state shall include: The successful completion of the following components in grades nine (9) through twelve (12), as evidenced by passing grades or by the successful performance on competency-based equivalency examinations:
  - (i) Four (4) school years of English;
  - (ii) Three (3) school years of mathematics;
  - (iii) Three (3) school years of science; and

- (iv) Three (3) school years of social studies, including history, American government and economic systems and institutions. Business instructors may instruct classes on economic systems and institutions.
- (b) Satisfactorily passing an examination on the principles of the Constitutions of the United States and the State of Wyoming.

### Section 5. District Assessment System.

- (a) Public school students shall be assessed in the uniform student content and performance standards at the level set by the state board of education in the following areas of knowledge and skills, emphasizing reading, writing and mathematics in grades one (1) through eight (8).
- (b) The assessment system shall be designed to best meet the needs of individual Wyoming school districts for demonstrating whether or not students have mastered the common core of knowledge and skills as reflected in the uniform student content and performance standards as specified in Chapter 10 of the Wyoming Department of Education rules. The assessment system described in this section shall be designed for grades one (1) through twelve (12) and be aligned with the uniform state standards, both in terms of content and cognitive complexity.
- (c) Districts shall provide students with disabilities accommodations in accordance with their individualized educational programs or 504 plans. These accommodations shall not substantially alter the character of the assessments used to measure student performance.
