Then click on the Assessment Confidential link located in the blue Data Reporting Links box on the left side of the screen. All of the Assessment Confidential reports currently available in Fusion will display. All reports are filterable by school year. Because of the large quantities of data, some of the reports take a few moments to load.

If you are having issues logging into Fusion or viewing the Assessment Confidential link, please contact your district's Fusion Administrator. District Fusion Administrators have been advised of the appropriate Fusion rights required to view the reports.

The 2012-13 Public PAWS reports are tentatively scheduled to be released by the Interim Director of the WDE, Jim Rose, on Wednesday, August 1, 2013.
