RELEASE OF WORKFORCE DATA QUALITY INITIATIVE REPORT – PHASE 1

The Wyoming Department of Workforce Services and Wyoming Department of Education will release Phase 1 of the Workforce Data Quality Initiative Report (WDQI) at 8 a.m. on May 4, 2015. Answers to frequently asked questions are listed below.

What is it?

The WDQI Report – Phase 1 is based on research conducted by the Wyoming Department of Workforce Services Research & Planning Division.

The report describes, statistically, the number of Wyoming high school students working and what they earn. It also attempts to identify what Wyoming high school students do after they graduate and determine how the labor market, economy, and life choices impact not only workforce decisions, but why students might choose to stay or leave Wyoming.

Please note that county-level data is the smallest population used for this report.

Why was it done?

The purpose of this study is to address questions regarding education and workforce development in Wyoming. In 2015, one of the priorities of the state legislature's Joint Education Interim Committee is to "concentrate its study on workforce development and preparation", see http://legisweb.state.wy.us/ htt

Which findings will be included in Phase 1?

- Percentage of 2009-10 Wyoming high school students to attend a post-secondary institution the year after high school graduation
- Average annual wage for students who graduated in 2010 the year immediately following completion
- How the earnings of Wyoming students compare to the statewide average for all people in the same age group
- Percentage of students with an IEP who participate in the workforce during and after 12th grade
- Percentage of students with a disability who participate in the workforce during and after 12th grade
- How students' with disabilities participation in the workforce compare to the general student population
