NATIONAL BOARD CERTIFIED TEACHER PAID REPORT NOW AVAILABLE

SUBMISSIONS DUE JANUARY 1, 2016

The School Year 2015-16 National Board Certified Teacher Paid Report (WDE112) is available on the Data Collection Suite – Forms Inventory page of the Wyoming Department of Education website.

The form can be accessed at edu.wyoming.gov/dcs/default.html. After clicking on this link, scroll down to the WDE112 report and click on the arrow to the left. The WDE112 form can be found in the Documents tab and must be downloaded to complete. This form is used for reimbursement of National Board Certified Teacher (NBCT) payments pursuant to W.S. 21-7-501(f). This collection will be open for data entry through January 1, 2016.

W.S. 21-7-501(f) states,

“...each district employing a national board certified teacher shall be reimbursed for payments to these teachers subject to the following:

(i) For each year the certificate is valid, the district provides each teacher employed by the district and holding certification by the national board for professional teaching standards a lump sum payment of four thousand dollars (\$4,000.00) which is in addition to the teacher's annual salary as determined by the board, and which is paid to each certified teacher between December 1 and December 31 of the school year for which application is made under paragraph (ii) of this subsection;

(ii) Effective school year 2007-2008 and each school year thereafter, the teacher holding certification shall be employed by the district full-time as a teacher. For purposes of this subsection, "teacher" shall include employees of the district holding certification and employed full-time as instructional facilitators, certified tutors, librarians or counselors;”

The Department will reimburse districts exactly \$4,000.00 per qualifying teacher before February 15, 2016. It is a local school district decision whether to pay the gross or net amount.

The last day to submit the WDE112 is January 1, 2016. Please read the instructions regarding each data element and fill the form out completely. In the event no certification number has been issued because a teacher was newly certified, please leave the certificate number and certificate expiration date blank on the WDE112. Email the newly certified teacher's eligibility letter from the National Board for Professional Teaching Standards (NBPTS) to Jed Cicarelli at jed.cicarelli@wyo.gov. If a teacher has been previously certified in another state or school district, please have the teacher update their profile on the NBPTS's website (<https://nbptsprod.zapsol.com/nbric/>) to reflect their current information so both the Department and the NBPTS have the most current information.
