SUBJECT: Public Comment on Chapter 3 Rules of Practice and Procedure

WDE SEEKS PUBLIC COMMENT ON CHAPTER 3 RULES OF PRACTICE & PROCEDURE

The Wyoming Department of Education (WDE) is seeking public comment on the Chapter 3 Rules of Practice and Procedure, which address the procedures for contested cases that may be brought before the Wyoming Department of Education or the State Board of Education, as applicable. The last revision of these rules occurred in 2007, and the proposed revisions reflect clarification to the process for contested case proceedings and incorporate by reference the Office of Administrative Hearings [Chapter 2 Rules: Uniform Rules for Contested Case Practice and Procedure](#) (October 17, 2014). Also included in the Chapter 3 revision is the process for the informal review of the school performance ratings under the Wyoming Accountability in Education Act for a school wishing to have their performance rating reviewed by the State Board of Education pursuant to W.S. 21-2-204(d)(vi).
