SUBJECT: Title I Committee of Practitioners Call for Participation

TITLE I COMMITTEE OF PRACTITIONERS - CALL FOR PARTICIPATION

Section 1603(b) of ESEA as amended by ESSA requires that each state receiving Title I funds have a Committee of Practitioners (CoP) who provide advice to the state from practitioners and stakeholders on the implementation of the Title I program. The CoP will provide ideas and recommendations for implementation, reviewing guidance, and rules, or regulations promulgated by the state that impact Title I.

ESEA requires that the majority of the members come from school districts and may include the following:

- Federal programs administrators
- School and District Leaders
- Teachers (both from public and charter schools)
- Parents
- School Board Members
- Private School Representatives
- Pupil Service Personnel

Members will be appointed by Superintendent Balow from applicants having expressed an interest in serving on the committee. Membership is for a two-year term.

The Committee will meet at least twice a year, either by video conference or face-to-face. The Committee will determine if additional meetings are necessary.

Please share the application with any school district personnel, private school personnel, or parents that would be beneficial to the Committee of Practitioners.

Applications and a resume must be received by the WDE by December 15.
