SUBJECT: Pilot Student-Centered Funding Program

US DEPARTMENT OF EDUCATION PILOT STUDENT-CENTERED FUNDING PROJECT

The US Department of Education (USED) has announced a pilot program that will allow school districts to combine eligible Federal funds with State and local funds to create a single, student-centered funding system. In the context of the pilot, this funding system is based on weights that allocate substantially more for students from low-income families, English learners, and other educationally disadvantaged student groups. The USED can approve up to 50 school districts to participate in this pilot program.

An LEA applying by July 15, 2018, will be proposing a system that would be implemented in the 2019-2020 school year, which provides time for transition to implementing an approved plan. USED is eager to receive applications from interested LEAs who share our enthusiasm about the program, the flexibility it gives local leaders, and its potential impact on equity and transparency in resource allocation.
