PUBLIC COMMENT OPEN ON TRANSPORTATION RULES. PUBLIC HEARING SET FOR AUGUST 20.

The Wyoming Department of Education (WDE) is promulgating revisions to **Chapter 2** and **Chapter 20** rules and seeks public comment. The comment window will be open from July 3, 2019 through August 17, 2019.

During the 2019 Legislative Session, <u>HEA0125</u> repealed the moratorium on the purchase of student transportation vehicles and required the WDE to:

- Define procedures for, and conditions under which school districts may procure student transportation vehicles.
- Establish a mileage and age replacement schedule for student transportation vehicles.
- Establish a competitive bid process for student transportation vehicle procurement.

The proposed Chapter 20 rules are a result of these legislative mandates.

The Chapter 2 proposed rules are updated to incorporate industry standards that maintain or further enhance the safety, security, and efficiency of student transportation. The proposed revision of Chapter 2 rules incorporates National School Transportation
