# EDUCATOR INPUT ON THE PROPOSED 2021 WYOMING HEALTH AND PHYSICAL EDUCATION CONTENT AND PERFORMANCE STANDARDS

The State Board of Education (SBE) requests public and educator input on the **2021 Health Education Content and Performance Standards** and **2021 Physical Education (PE) Content and Performance Standards**. Content Standards are what students should know and be able to do, and Performance Standards specify the degree of understanding. Performance Standards are a subset of the Proficient Performance Level Descriptor (PLD) statements that are tied to the Content Standards on which districts are expected to assess all students through the district's assessment system.

Many educators teach both Health and PE. Educators may choose to answer both or only one of the surveys. Respondents may select the grade bands on which they wish to comment. Educator Input may be collected in writing through the survey or verbally at the Public Input Meeting.

### For Educator Input on Health Standards and Physical Education Standards:

- Review the Proposed **2021 Health Education Standards**.
  - Complete the **Health Standards survey** by July 28, 2021.
- Review the Proposed **2021 Physical Education Standards**.
  - Complete the **PE Standards survey** by July 28, 2021.

- Attend a virtual Public Input Meeting. The first 15 minutes will be an informational presentation, and the remainder of the time will be to collect input. Attendees may enter and exit the Zoom meeting at any time during the block.
