Schools have rising unpaid meal bills

Hillsborough officials are seeking a collection agency to get parents to pay up for lunches charged to their kids.

TAMPA - Stuck with an unpaid tab of over \$500,000, the Hillsborough school system plans to hire a collection agency to get deadbeat parents to pay for all the chicken nuggets and dinosaur potatoes their kids are consuming gratis.

"We work with people, but some just don't pay," said Hillsborough School Board chairman Glenn Barrington.

Administrators sought bids for the collection work last fall, but ultimately were not satisfied with the terms they were offered. School officials still hope to negotiate with a collection agency by the end of the school year, or at a minimum, improve their own methods for collecting on unpaid meals.

The idea to hire an outside firm grew out of a discussion in the fall by board members, who were shocked to learn that the district absorbed the loss of \$575,000 in uncollected revenue last year from parents who did not pay for meals.

The debt appears to be an escalating problem. In 1996, Hillsborough lost \$112,000.

Unpaid lunch money is a problem Columbus City Schools said it's been trying to address for over two years with little to show for it.

Now parents owe more than \$1 million to the school lunch fund and the district is ready to take them to collections.

"The district has taken several steps over the years to try and reduce this debt. It's a growing problem that reflects families' economic struggles nationally, says Dora Rivas, president of the School Nutrition Association.

"When we're talking to parents, we're hearing that they lost their jobs, their cars have broken down," says Sheila. Mason of Des Moines Public Schools

About 4.500 students in Des Moines owed \$133.000 for unpaid meals at the start of the year, most of it from previous years. That's more than twice the amount a year earlier.

2012 Legislative Issue Paper

Since 1946 the National School Lunch Act has functioned successfully as a grant-in-aid program. Continuing the historic support for child nutrition, the Healthy, Hunger-Free Kids Act of 2010 (P.L. 111-296) made a number of important changes to strengthen the programs. The statute, among other things, limited indirect expenses, established professional standards and required nutrition guidelines for all competitive foods and beverages sold in schools.

In order to fully embrace these changes, in a fiscally challenging environment, we ask Congress to consider the following:

Unpaid meal charges owed to the School Food Authority (SFA) by families participating in the program have increased significantly. Congress should require USDA to establish a consistent, national policy on how to address the debt incurred by the unpaid meal charges.

2012 SNA Legislative Issue Paper Talking Points

Unpaid Meal Charges: Congress should require USDA to establish a consistent, national policy on how to address the debt incurred by unpaid meal charges.

- School nutrition programs have experienced an increase in the number of children who "charge" their
 school meals when parents fail to pay for school breakfast or lunch. As a result, some schools have
 accumulated substantial unpaid meal debts, threatening their ability to cover the cost of meeting new
 federal nutrition standards for school meals. To make matters worse, the paid meal equity provision of
 the Healthy, Hunger-Free Kids Act forced some schools to raise meal prices regardless of local
 economic conditions. Schools often see a rise in unpaid meal charges as a result of price increases.
- Currently, individual school districts must determine if students will receive alternate or unpaid meals, how many meals can be charged and how to handle meal charge debts. Congress should require USDA to establish clear regulations on how all schools must respond to requests for unpaid meals and how to manage the debt incurred by providing them.

 - Total Balances (Free, Reduced, Full Pay) <\$11, 313>
 - 35% Free families
 - Up \$3,400 from previous year
- Current FY \$8,080
 - High School recovered \$1,676 in funds.

- Hopkins Public Schools decided to form a Negative Balance Task Force
 - Who was involved?
 - 16 member task force made up of food service staff, principals, counselors, interpreters
 - How often did we meet?





- Why get involved?
 - Signs of Hunger
 - Students Struggling to Focus
 - Fast Eating
 - Distracted
 - Often Sick



- What were the goals?
 - Identifying and assessing the situation
 - Help the parents/guardians meet their responsibilities
 - Determine roadblocks
 - Develop future methodology and proper delivery systems to meet the challenges of our community.



- What were the results? Admin Office
 - Continued representation at orientation/back-to-school days
 - Online Educational Benefits Application.
 - Continue to develop ways to reach ESL families
 - Educate Families and School Staff (Compensatory Revenue)
 - Quarterly Cashier Meetings
 - Automated Negative Balance Calls
 - Once a week on all negative accounts (Wednesdays)
 - Once a week on all Elementary under \$8.00 (Thursdays)
 - Once a week on all Secondary under \$10.00 (Tuesdays)



- What were the results? Admin Office
- Created best practices for cashiers
 - Daily
 - » Review negative balances prior to lunch service
 - » Call the Guardian of students with negative balances
 - » During lunch service, remind students of negative balance (send envelope with student as reminder)
 - Weekly
 - » Review with school administration
 - » Work with Counselors and Student Liaisons





- What were the results? Admin Office
 - Created Cashier Log Book. Mandatory for all cashiers to use.
 - Copy of Standard Operating Procedures
 - Copy of Meal Charge Guidelines
 - » High School has separate one from JH & Elem
 - Copy of Visiting Students & Guest Meal Guidelines
 - Visiting student/guest meal log
 - Monthly Tabs with Negative Balance log per month



- What were the results? Admin Office
 - Cashier Log Book Negative Balance Log

- What were the results? Admin Office
 - Cashier Log Book Negative Balance Log

- What were the results? High School
 - Added Self Addressed envelop for families
 - Representation at High School orientation
 - HS Kitchen staff to work closely with students and counselors when contacting parents.
 - Create a process to eliminate students from going to a cash line when meal account is negative.



- What were the results? Jr. High & Elementary
 - Utilize ELL specialists at Orientation/Back-to-School Days.
 - Create uniform Open Houses.
 - Make sure all cashiers create and maintain relationships with school offices, counselors, equity specialists.
 - Collect \$10.00 up front from families to pay for meal charges before application is processed.
 - Provide applications in all necessary languages
