On July 31, 2018, the President signed the Strengthening Career and Technical Education for the 21st Century Act into law. This bill reauthorizes the Carl D. Perkins Career and Technical Education Act of 2006 (Perkins) and will be referred to as Perkins V. Perkins is dedicated to increasing learner access to high-quality Career Technical Education (CTE) programs of study. With a focus on systems alignment and program improvement, Perkins is critical to ensuring that programs are prepared to meet the ever-changing needs of learners and employers. Join us in an intro course to the new Perkins V Act going into effect July 1, 2019. We will also be taking a closer look at the monitoring process and checklist for Perkins onsite visits - you'll learn what documentation you should be keeping every year, and helpful tips to avoid findings in the future.
