Findings and Corrective Actions:

700 – Resource Management

Finding #1

Per the PLE tool the SFA was to either increase lunch by \$.10 or contribute at least \$2,605.20 of non-federal funding to the school lunch account. Neither was done. Copy of PLE memo informing SFA of requirements is attached.

Required Corrective Action:

Either increase lunch prices by at least \$.10 or contribute at least \$2,605.20 of non-federal funding to the school lunch account. However, the price increase was for this school year and the increase may need to be higher for 19-20. Please inform WDE which action will be taken.

Accepted Corrective Action:

Sponsor submitted response with action that St. Mary's contributed funds in non-federal funding to the lunch program, and is also planning on increasing lunch prices for the 2019-202 school year. Corrective Action is approved.

Finding #2

Documentation was provided for the week of the on-site only. Site will provide nutrient data, completed compliant recipes, and completed nutrient analysis to include all foods served for review week (December 10, 2018 and January 22, 2019).

Required Corrective Action:

Agency will provide Nutrient data (either CN labels or product formulations statements) completed compliant recipes and completed nutrient analysis for the week of December 10, 2018 and January 22, 2019. Also, please provide completed production records for the two requested weeks. For the recipes, please add instructions and HACCP process to them.

Accepted Corrective Action:

Sponsor provided the month of January's weekly lunch data and forgot to submit December's information. Since the review, all requested information has been uploaded for December along with the week of January 21 - 25, 2019. Corrective Action is approved.
