Findings and Corrective Actions:

100 - Certification and Benefit Issuance

Finding #1

There is no determination delivery date of benefit issuance for 4 applications. This is needed to ensure that the status is being determined within 10 days of receiving the application. One application was missing SSN.

Required Corrective Action:

Record determination delivery date for these students in the online system for SA to verify. Going forward, be sure to record the determination delivery date. Also, retrieve SSN for application.

Accepted Corrective Action:

Sponsor will contact Pay Schools to determine why online applications do not have determination delivery date on the application summary page. Sponsor uploaded completed application with SSN. Corrective Action is approved.

Required Corrective Action:

Make sure and add this product to your Buy American exemption list and attach documentation of updated list to this corrective action, and contact Sysco to update their list of non US grown products.

Accepted Corrective Action:

Sponsor has uploaded an updated Buy American exemption list. Corrective action is accepted.
