19-20 Applications

- Applications must be in no later than July 1, 2019 to be considered substantially approvable
- They do not need to be approved, just submitted
- Please remember to review your GEPA narratives

18-19 Funds Obligated/Drawn

- Funds must be obligated no later than 9/30/2019
- Funds must be drawn by mid December

Home Language Surveys

The Home Language Survey (HLS) requirements have been updated for the 2019-20 school year.

- It is unnecessary to ask parents to complete a HLS each year when a student is in the same district, as it can lead to a student being misidentified for English Learner (EL) services

Exemption Request Process for Active ELs Who Have Been Overidentified or Misidentified

EL Override Status Tool Working

- Student exited from EL status, district will be notified via email
- Districts will view information for accuracy
- Goal is to have most exceptional cases completed by the August
- WY-Ed Administrators will need to assign WY-Ed Accounts for District EL Coordinators
 - There can be more than one WY-Ed Account
 - Primary (will be on the directory)
 - Others will have access, but not on the directory

Transfer Records

- Every attempt to obtain records from the previous district or state must occur to verify that the student is not already an active EL or on monitoring status
- EL District Coordinators will be added to the search directory,
 WDE609

Assessment Confidential Role for EL District Coordinators

- District WyEd Administrators may assign EL Coordinators the Assessment Confidential Role
 - This will give access to the accountability reports, summary reports, and school performance report EL indicators
- This role can be assigned at the district or the school level
- To find your WyEd Administrator; click this <u>link</u> and search by your district name

ACCESS Proficiency Criteria

- An overall Composite Performance Level (CPL) score of at least 4.6 A Literacy Performance Level (LPL) of at least a 4.3 (new additional criterion)
- Superintendent's Memo
- EL Letter to districts

Change in the ELP Assessment Name

- 18-19 is the last year for ACCESS 2.0
- 19-20 will then be just ACCESS

What's coming in 19-20 and beyond!

WIDA K-Screener in Spring 2020

- Developed two parallel versions of the assessment
- Paper and pencil, one-on-one administration
- Oral language version + four-domain version
- 14-18 minutes to administer oral language test
- Replaces K W-APT

Volunteer States Needed for Field Test WIDA K-Screener

- Now selecting items to move from pilot to field test
 - Phase 2 FT (Jan-Feb 2020)
- Districts contact Antoinette to volunteer


Current Writing Task Layout

- ACCESS Enhancements
 - An embedded online writing field test
 - Shifting from TSM to Central Office Services, Service Device (COS-SD)
 - Screener data export capability (release date not final)
 - A change in the ISR to support faxing
 - The final consolidation of paper BC forms
- Refreshing the English Language Development Standards in 2020

ALT ACCESS Revamp

- * Part of Competitive Assessment Grant (CAG) submitted 3/19 for update of ALT ACCESS
 - Update Alternate ACCESS
 - Develop alternate achievement standards for English learners with significant cognitive disabilities
 - There will be a K ALT ACCESS and Screener beyond the school year
 - Develop Alternate Can Do Descriptors

Participation Rate for English Learners on the ACCESS Assessment

(New in SY 19-20)

Participation Rate Requirement

A participation rate requirement of 95% is required for all students on the ACCESS and ALT ACCESS.

Participation Rate Calculation

Participation rate is calculated by the number of students who tested divided by the number of students who should have tested at the school.

Participation Rate Adjustment

There is an adjustment rule that is employed when determining a school's participation in testing to ensure that no school is held above the 95% requirement.
