## REPORTING AND FUNDING FOR STUDENTS PLACED OUT-OF-DISTRICT

The intended purpose of this document is to guide districts with reporting and funding questions following student placement decisions. It should NOT be used to make programatic decisions for students. Additional guidance may be required on a case by case basis. DISCLAIMER: Guidance provided in this document is intended to provide assistance for most situations.

NOTE: In cases of COMPS placement the resident district may change, if another district is specified in the court order. Students placed at a BOCES facilities will fall under IEP or COMPS Placements.
