Reporting

Irregularities

IRREGULARITIES MUST BE REPORTED TO WDE:
[Irregularity Report Form \(IRF\)](#) must be completed by DTC.

- [Example of irregularities](#) include, but are not limited to:
 - Student completes an incorrect writing test.
 - Student kicked out of a speaking test.
 - Test Administrator did not complete scoring of writing.
 - A student shares that the mic was staticy-speaking test.
 - The student didn't push Next at the end of the Speaking test and logged out of the testing platform.

Data Validation

- WHEN: Data Validation Window: Monday, March 18th to Friday, March 29.
- WHAT: Review the data for all students and validate.
- WHO: Completed by the District Test Coordinator (DTC); Permissions to Building Coordinator/others.
- HOW: [WIDA AMS User Guide Supplement for Data Validation](#) in resources in the WIDA Secure Portal.

Student Not Tested Form (SNTF)

- **WHAT:** If student did not complete all or any portion of the ACCESS or ALT ACCESS domain tests, the DTC submits the [Student Not Tested Form \(SNTF\)](#) to WDE.
- **WHEN:** After the ACCESS testing window has ended by March 15, 2024.
- **WHY:** The information collected from this form will help mitigate data discrepancies, inform future assessment administration guidance.

- ONLINE REPORTS: 5/2/24.
- PRINTED REPORTS: 5/20/24-5/22/24.
- DOMAIN EXEMPTION CUMULATIVE SCORES: 6/2/23.

WDE684 EL Collection

- EL Reporting WDE684 Collection 3 Times a Year:
 - October completed.
 - March 1 to March 14, 2024.
 - May 17 to June 28 2024.
- Done through district Student Information Systems (SIS).
- Compares information from WDE684 report & district records for compliance issues.

EL Reporting March WDE684

- March 1, 2024-March 14, 2024 School districts report English Learners.
- ERROR REPORTS: start on March 17, 2024.
- The WDE684 Spring collection will be made available for opportunities to make corrections from March 15-March 28, 2024
- March 28: End date to fix errors.

[ACCESS for ELLs Checklist](#) in the Wyoming WIDA webpage includes all steps (before, during, and after testing).

After testing information included on:

- Secure Material Tracking Report in WIDA AMS under Reporting Services > Published Reports for a full list of all materials sent to your school/district and returned to DRC.
- Data Validation
- Score Reports

Individual English Learner Plans (IELPs)

- WHO: IELP for each EL student created by language support team.
- WHAT: Should be individualized.
 - Accommodations and Supports needed in classrooms, assignments, and on district tests.
 - Needs on State Assessments.
 - Goals, progress and monitoring.
