Providing Support: WDE to LEAs

Types of Support

Guidance and Policy Clarification

Clear guidance documents, policy briefs, and FAQs to assist LEAs in understanding and complying with state and federal regulations, including interpreting relevant legislation.

Professional Development

Ongoing learning opportunities, such as sessions, webinars, and online courses, focused on curriculum development, instructional strategies, and the implementation of HQIM and HQIP.

Data and Accountability Support

Assistance with collecting, analyzing, and using data to inform decision-making, alongside training on data interpretation and support for local accountability planning.

Funding Guidance and Management

Technical support for managing state and federal funding streams, including assistance with grant writing, budget planning, and compliance monitoring.

Curriculum and Instructional Support

Development and dissemination of curricular frameworks, model lesson plans, instructional resources aligned with state standards, and coaching services to support effective implementation.

Compliance Monitoring and Support

Technical assistance to ensure compliance with education laws, including audits and guidance.

Technology Integration and Support

It is important to collaborate with the WDE throughout this process to streamline implementation and ensure that staff are supported. This partnership strengthens the alignment between local and state goals, promoting the most effective and efficient use of resources.

Next, LEAs should establish a clear dissemination plan to effectively communicate the WLLP to school leaders and educators. A clear, consistent communication strategy is essential for successful implementation. Research by Durlak and DuPre (2008) emphasizes that the dissemination of evidence-based practices with fidelity requires coordinated messaging that ensures all stakeholders have a uniform understanding of the plan's goals and procedures. Working closely with WDE during this process ensures consistency in messaging across the state, fostering a shared understanding and commitment to the plan. A well-structured dissemination plan will help school leaders and educators grasp the importance of the WLLP, ensuring its effective execution at the local level. LEAs are encouraged to reach out and make full use of the technical assistance available through WDE, ensuring that they are fully supported in this process.

Maintaining open communication with WDE is essential for continuous improvement. LEAs are encouraged to provide regular feedback throughout the implementation process, especially by sharing successes and challenges from the classroom. This feedback is invaluable, as it ensures that those directly involved in the implementation—teachers and educators—are heard and supported. Additionally, LEAs should work with WDE to establish procedures for consistent data collection, analysis, and reporting. Involving educators in the data analysis process helps refine instructional practices and supports the ongoing improvement of the literacy plan.
